

**ST IVES HARBOUR AND BAY – G7 SUMMIT 2021**  
**REGISTERED FISHING VESSEL REGISTRATION PROCESS**  
**AND TERMS AND CONDITIONS**

To Fish using a Vessel within St Ives Harbour and St Ives Bay (excluding Hayle Harbour) between the 00.01am 8<sup>th</sup> June and 11.59pm 15<sup>th</sup> June the Vessel must be a Registered Fishing Vessel and the Master of it must be a Registered Master (in both cases as defined in the St Ives Harbour and Bay – G7 Summit General Directions 2021).

In addition every person on board the Registered Fishing Vessel must comply with these Terms and Conditions.

Failure to comply with the above is a breach of General Direction 8 and punishable by a fine of up to level 4 on the standard scale. In addition, the Vessel in question will be directed to leave St Ives Harbour and St Ives Bay and only permitted to return once the above requirements are complied with.

### **1. Registration Requirements**

For a Vessel to be granted Registered Fishing Vessel status, the person wishing to register the Vessel must provide to the Harbour Master ([harbouroffice@cornwall.gov.uk](mailto:harbouroffice@cornwall.gov.uk) or St Ives Harbour Office, Smeatons Pier, St Ives, Cornwall, TR26 1LP) in writing **a minimum of 72 hours before the vessel wishes to fish in St Ives Harbour and Bay:**

- A. Evidence that the Vessel is registered with the Maritime and Coastguard Agency (MCA) and licenced by the Marine Management Organisation as a UK Fishing Vessel.
- B. A photograph of the Vessel that clearly identifies it.
- C. The name, date of birth, address and photographic ID (passport or driving licence) or such other means of identification as agreed for:
  - **the person or persons who will be the Master of the Vessel whilst it is within St Ives Harbour and the Bay** – clearly identifying that those person(s) will potentially be acting in the capacity of Master;
  - **all other persons who will be or will potentially be on board the Vessel whilst it is within St Ives Harbour and the Bay.**

### **2. Registration Process**

The information provided, including all personal data relating to those persons named, will be used for the purposes of national security, specifically to carry out verification checks on the vessel and persons named in the application.

The information provided will be shared with the police and other UK security services for the purpose of law enforcement, vetting, ID verification and national security.

The Police and Security Services will run the required security checks before providing confirmation in writing to the Harbour Master that all persons that will be on board the vessel have been approved for clearance.

The Council will check that the evidence provided to establish that the Vessel is registered with the Maritime and Coastguard Agency (MCA) and licenced by the Marine Management Organisation as a UK Fishing Vessel is sufficient,

Once the Council is satisfied that the vessel is registered with the Maritime and Coastguard Agency (MCA) and licenced by the Marine Management Organisation as a UK Fishing Vessel and, it has received clearance from the Police or Security Services that the security checks have been completed and are acceptable the Council will then grant to the vessel Registered Fishing Vessel status.

The Master(s) will also be granted 'Registered Master' status. The Council will provide a written registration document to the Master of the vessel to confirm both registrations. The written registration will include a list of all persons permitted to be on board the Registered Fishing Vessel when it is within the Registered Fishing Vessel Area or fishing (or intending to fish) within St Ives Bay (excluding Hayle Harbour) and the Harbour.

If any additional persons need to be authorised to be on board the Registered Fishing Vessel, their name, date of birth, address and photographic ID (passport or driving licence) or such other means of identification as agreed must be provided **a minimum of 72 hours before the person wishes to be on board the vessel.**

They will not be authorised to be on board the Registered Fishing Vessel until the above security checks have been completed and the Council has issued a new written registration document which lists their name on it.

### **3. Withdrawal of Registered Fishing Vessel status**

If any person on board a Registered Fishing Vessel breaches any of the Registered Fishing Vessel Terms and Conditions and / or has not been security cleared as part of the above registration process the Vessel's Registered Fishing Vessel status will be withdrawn and the Vessel will not be permitted to Fish within St Ives Harbour and Bay during the remainder of the period 00.01am 8<sup>th</sup> June to 11.59pm 15<sup>th</sup> June 2021.

## **4. Terms and Conditions**

### **A. PERSONS ON BOARD THE REGISTERED FISHING VESSEL**

Only persons named in a written registration document for a Vessel granted by the Council under paragraph 2 above, may be on board a Registered Fishing Vessel which is with the Registered Fishing Vessel Area or is Fishing or intends to Fish within St Ives Bay and Harbour (excluding Hayle Harbour).

## B. IDENTIFICATION DOCUMENTS

All persons on board a Registered Fishing Vessel must have with them on the Vessel their photographic ID (passport or driving licence) or such other means of identification as agreed.

## C. COOPERATION WITH THE HARBOUR MASTER, POLICE AND SECURITY SERVICES

All persons on board a Registered Fishing Vessel must cooperate with any request of the Harbour Master, Police or Security Services (including stopping the vessel) and produce their photographic ID if asked to do so.

## D. SPECIAL DIRECTIONS OF THE HARBOUR MASTER

The Master of a Registered Fishing Vessel must comply with any Special Direction of the Harbour Master, including moving the vessel to any location within St Ives Harbour and Bay (excluding Hayle Harbour) the Harbour Master directs.
