Insurance requirement: Every boat owner shall have in force for the whole of the period of the licence a valid insurance policy with an insurance company satisfactory to the Council against any claims which may be made by any passenger, hirer or any other third party. The boat owner shall request the insurance policy to endorse on each policy the Cornwall Councils interest. No licence shall be issued until such insurance policy has been produced. Insurance shall be not less than £3,000,000 in respect of any one incident and shall be renewed as may be necessary.				
I understand that the submission of this application form and payment of the fee does not entitle me to operate a boat for hire until the license has been issued. I undertake to notify the Council when my boat and equipment are ready for inspection and to supply the necessary details of insurance cover along with signed certificates of seaworthiness and engine inspection. Your information will be kept from first application and for up to a maximum period of 6 years.
